Sub/विषय:- Notice to NRS Linkage FSA Consumers whose Level of Lifting is below 30% against its respective ACQ during FY 2025-26

As per the provisions of the NRS Linkage Fuel Supply Agreement (FSA), WCL (Seller) has the right to terminate an FSA in cases where the Level of Lifting by the Purchaser falls below 30% of the Annual Contracted Quantity (ACQ) during a financial year. It has been observed that the purchasers listed in the attached table have failed to lift the minimum prescribed quantity of coal, i.e., 30% of their respective ACQ during FY 2025-26. Accordingly, the provisions of Clause 17.2(d) of the FSA are attracted in these cases.

In terms of the aforesaid clause, notice is hereby served upon the NRS Linkage FSA holders, as detailed in the attached table, whose Level of Lifting during FY 2025-26 has remained below 30% of their respective ACQ.

Further, as provided under Clause 17.2(d) of the FSA, the concerned purchasers may avail the option of keeping their FSAs alive by depositing the applicable penalty calculated in terms of Clause 5.6 of the FSA or an amount equivalent to the Security Deposit (Performance Security), whichever is higher, subject to submission of the requisite request and undertaking within the prescribed time period.

The purchasers are advised to take appropriate action within the stipulated period, failing which further action, shall be taken as per the provisions of the FSA.
