The National Board of Examinations in Medical Sciences (NBEMS) has accredited Central Hospital, Jagjivan Nagar, Dhanbad and Central Hospital, Gandhinagar, Kanke for the following Post MBBS Diplomate of National Board (DNB) and Post MBBS Diploma Courses. The seats are to be filled by CIL at its own level from NEET-PG 2025 qualified in-service candidate. Central Coalfields Limited (CCL) is the nodal subsidiary for counselling and selection of seats for Coal India Limited (CIL) candidates.

Eligibility Criteria for In-Service Doctors

- The candidate should be regular executive cadre employee of CIL of Medical Discipline and should have completed 01 year of mandatory probation period.
- He/ She should have passed MBBS and appeared in NEET (PG) in the year for which he/ she has applied for DNB/Diploma. Candidate should submit his/her merit ranking.
- Only those candidates can apply who are not due to reach the age of superannuation from the service within five years from the date on which he/she is expected to return to duty after the completion of the DNB/Diploma Course or age limit as per prevailing NBE Guidelines, whichever is less.

- For the Diploma/DNB seat of CIL, internal candidate, allocation of seat will be as per merit list based on the ranking obtained in NEET (PG) in the year for which he/she has applied for.
- They should not be long absentees and their VC/DC should be clear. The selected candidates should execute Bond as prescribed.

General Terms and Conditions:

- Within 7 days of joining the DNB/Diploma course, the candidate must execute a bond committing to repay the full amount of salary incurred by the company during the period of the respective course, along with applicable interest, in the event that they fail to serve the company for a minimum period of 5 years after completing the respective course.
- The in-house candidate of CIL will continue to draw salary during the DNB/Diploma course. They will not be entitled for stipend as stipulated for external candidate.
- During the Diploma/DNB course, company owned accommodation/ hostel will be provided to the candidate. Various accommodation charges viz. electricity, water etc. will be borne by the candidate as per company rules.
- During the respective course, the in-service candidates are entitled for availing all applicable leave as per CIL Leave Rules, however, it will be subject to ceiling of 30 days in a year excluding duty off and PHDs (as per NBE guidelines).
- Candidates selected will be posted at Central Hospital, Gandhinagar/Central Hospital, Dhanbad on temporary basis during course period. During the temporary posting of candidate, they would not be eligible for deputation allowance.
- After completion of 03 (three)/02 (two) years course, the in-service candidate will return back to their original place of posting/ Subsidiary and join duty.
- If the candidate resigns or retires from service or otherwise quits service without returning to duty after the completion of respective course or within a period of 5 years after such return to duty or fails to complete the course of study, he/she shall be required to refund the actual amount of salary, incurred by the Company on him/her during the period of DNB course together with interest thereon at rates for the time being in force before his/ her resignation is accepted or permission to retire or his/her quitting service is granted.
- For any misconduct, it will be dealt as per Coal India Executives' Conduct, Discipline and Appeal Rules and NBE Guidelines for in-service candidates.

Financial (Training Charges & Fee Guidelines)

1. The fees shall will be collected annually and has to be paid by the trainee at the start of each academic year.
2. In the 1st year the fees have to be paid on joining the hospital while the fee for 2nd & 3rd year (as applicable as per the course) has to be paid within 4 weeks of the start of the academic year.
3. The fee shall be paid by the candidate only through electronic transfer and under no circumstances in cash.
4. As per Agreement with NBE, the following is the training charges/fee structure for DNB & FNB which are to be borne by the In-Service Doctors.
 - Tuition fees Rs. 75,000.00 per annum
 - Library fees Rs 15,000.00 per annum
 - Appraisal fees 15,000.00 per annum
 - Accommodation Charges 20,000.00 per annum
